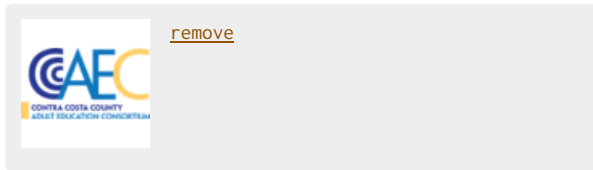

Rationale

A workgroup was formed to review and discuss the budgets and fiscal structure and to make a recommendation to the steering committee. After discussion around the work involved to maintain separate records for funding years, develop common budget codes and reporting, and manage the common cost funds, the majority agreed it best to maintain the fiscal agent for another year and revisit the option of direct funding for the following year.

Allocation Changes

Please describe any significant changes in allocations to members made for the 2015-16 and / or 2016-17 program years.

The allocation amount for the Contra Costa County Office of Education, of \$1,632,896 includes: \$490,700 for Contra Costa Adult School, and funds held for consortium-wide common costs of \$1,142,196. Out of consortium-wide common costs, the following one-time distributions were made to: West Contra Costa (16-17 funds of \$114,718), Liberty (15-16 funds of \$84,090), Martinez (15-16 funds of \$8,222), and Mt. Diablo (15-16 funds of \$73,000), as well as one-time reductions to Contra Costa Community College District (reduction of 16-17 funds of \$374,777).

Consensus and Approval

The Budget work group, along with the Governance work group, are establishing a process to determine future allocation amounts determined by student needs throughout the consortium, as well as member effectiveness. They will not have received the results of a pending gap analysis related to our original plan, at the time of this filing, and therefore, are carrying the numbers over from the prior year "as is" with the expectation that a process will be developed to distribute funds to members as needed.
