As Fiscal Agent, COM designates a portion of all monthly governance meetings to discussing invoice procedures, pass-through process, requirements, state reporting, activities of consortia colleagues specific to funding and related questions. Designated consortium workshops and

individual agency meetings with Fiscal Agent accounting representatives are planned and will ensure funding to flow seamlessly between agencies.

#### **Allocation Changes**

Please describe any significant changes in allocations to members made for the 2015-16 and / or 2016-17 program vears.

The Marin AEBG Consortium added a new Member, Shoreline Unified School District, to provide services to rural areas of Marin County that have not had adequate Adult Education Programs. The Marin County Office of Education reduced their allocation by \$13,000 and the College of Marin reduced their allocation by \$13,000 to provide the \$26,000 that Shoreline has budgeted to increase ESL courses in their district. For the 2017-2018 program year, the Marin AEBG Consortium voted to reallocate \$10,000 from Tamalpais Adult School to Novato Unified School District because currently Tamalpais Adult School is managing a GED program at Lynwood Family Literacy in Novato, but it makes more sense for NUSD to take over this program going forward with proper funding.

#### Consensus and Approval

Describe how you arrived at consensus and approval of the allocations provided in the table above.

Marin Consortium members were asked to consider 2016-17 and 2017-18 program expansion, development, new partnerships, and how these factors effect current and future allocations. At the 4/27/16 governance and again at the 4/05/17 governance meetings, members discussed 2016-17 and 2017-18 projected allocations. Changes to member allocations, including the addition of a new Member, Shoreline Unified School District, with an allocation of \$26,000 taken from Marin County Office of Education (\$13,000) and College of Marin (\$13,000) were unanimously approved for 15-16, 16-17 and

forward, and for reallocation of \$10,000 from Tamalpais Adult School to Novato Unified School District as they take over the previously TAS managing of a GED Program at Lynwook Family Literacy in Novato. Subcontracting was discussed as a means to program expansion by members for unplanned programming that aligns with AEBG guidelines.
