Fiscal Agent

Rationale

The West Hills Adult Ed Consortium selected to continue operating with West Hills Community College District as the fiscal agent for the upcoming 2017-18 year.

The decision to continue with this format was unanimous and no members shared any concerns. Members have confidence with West Hills' ability. They have large amounts of staff support that have experience dealing with various reporting formats and successfully administering large grant projects.

The fiscal contact, Maria Battisti and her lead assigned accountant have shared sample binders that include copies of all forms including back up documentation samples to assist each member. In person site visitations with each member assures good quality relations and clearer understanding of timelines and reporting needs.

Members believe the fiscal agent approach allows for much more trust and collaboration between the members; this includes openly sharing program curriculum, reporting assistance and information, and staff time when needed.

Fiscal Management Approach

The AEBG block grant is being fiscally managed by West Hills Community College District (WHCCD). A supervisor and a lead accountant has been assigned to maintain all fiscal information and track all expenditures and back up documentation.

These individuals perform site visits with each member district to ensure communication is clear and concise with regards to documentation.

Members turn in information to the fiscal agency on a schedule with all expenditures separated by expenditure, object code and programs/objectives.

Reporting activities are reported by assigned grant director David Castillo with fiscal reporting entered by fiscal administrator. Reports are reviewed and certified by Deputy Chancellor Ken Stoppenbrink.

Allocation Changes

Please describe any significant changes in allocations to members made for the 2015-16 and / or 2016-17 program vears.

The only significant fiscal change that has taken place was with the voluntary exiting from the consortium of Riverdale Unified who had been allocated \$64,500 + \$44,688 MOE. Those funds were reallocated to West Hills College to hire two consortium staff to assist all members with various duties including registrations, assisting students,

assisting staff, and following up on completing students to correctly document outcomes of education and/or jobs obtained.

Consensus and Approval

Describe how you arrived at consensus and approval of the allocations provided in the table above.

Members agreed to simply deduct all of the consortium level cost first; the cost of items includes fiscal agent indirect, consortium focused staffing wages and benefits, supplies, and travel for consortium related adult ed conferences and travel. The remaining funds are divided by 10 school sites, but only 9 are receiving the funds as the 10th portion (originally allocated to Riverdale) was reallocated to hire additional consortium level staffing. Members receiving MOE keep those amounts on top of the AEBG allocated funds.
